  - e. To deliver the peace education to sustain peace and friendship to the community to make this planet a better place to live and sustain.
  - f. To eradicate the malpractice of religion in the name of superstition.
  - g. To prepare a library on the subject of Enlightenment.
  - h. To publish the contents of the subject of enlightenment in various forms of document to its members.
  - i. To participate on religious conference throughout the globe for the true light of enlightenment - the base of different kinds of religions.
  - j. To empower the students of every age about the concept of enlightenment and their being on this planet.
  - k. To help in the research of the concept of enlightenment, consciousness and transformation.
  - l. To support various institutions, societies, organization and individuals who share equal thought about peace, freedom and humanity.
  - m. To foster vegetarianism and promote non-violence in the community.
  - n. To create society of divine peoples by uniting them and to make them aware about enlightenment and transformation.
  - o. To provide opportunity to the seekers who is interested in the enlightenment process and further bring awareness to the general mass.
  - p. To provide knowledge and information in the field of enlightenment, religion, consciousness, transformation subjects through the library, newsletter, publications or other documents.
  - q. To organize workshops, seminars, symposium and conferences for awareness of the subject of enlightenment and to uplift the minds of the student/child, so that they can become a good citizens and to develop the youth as a power.
  - r. To empower, strengthen and encourage the women society with new knowledge and information.

- s. In order to fulfil the above statements the Working Committee will organize different kinds of services from time to time.
  - t. To provide peace educations to the young adults by visiting their schools and participation to various events.
  - u. To acknowledge various persons who are working in the field of enlightenment and humanity.

## Rules

Who so ever possesses divine attributes male/female convinced with the objectives, policy and rules can become the member of the Working Committee.

The members will be categorized as

- Core Member
- Guardian (Sanrakshak)
- Assistant (Sahayak)
- Simple (Sadharahan)
- Teacher (Acharya)
- Student (Shishya)
- Seeker
- Special or Sponsored

### Core Member

The core members are the enlightened ones and shall be categorised in three kinds.

- Enlightened - First kind: Title of Hans, Paramhans
- Enlightened - Second Kind: Title of Parmanand, Sadbrahmanand, Kritvidh, Dristha etc.
- Enlightened - Final: Avatar, Guru.

They are selected by the Founder or the head of the Organization. There are no prerequisite qualifications for it. They are the Working Committee.

### Guardian (Sanrakshak)

Who so ever takes admission and completes his course and acquires 251 credit points in any form, that person will be life Guardian member of the Organization.

Guardian member shall be entitled to take part in the planning of the development and sustaining of the organization and be a part of Working Committee. After their enlightenment they shall become a core member.

## **Assistant (Sahayak)**

Who so ever takes admission and completes his course and acquires 151 credit points in any form, that person will be Assistant member of the Organization for a maximum of 10 years.

Assistant member shall be entitled to provide assistance in the development and sustaining of the organization. After their enlightenment they shall be a part of the guardians for one year and gradually to the core members. For this he/she has to apply his candidature to the working committee where the working committee shall decide him/her to be enlightened. Assistant members can take part in any seminars, conference or workshops freely and can nominate five members including family and friend.

## **Simple (Sadharahan)**

Who so ever takes admission and completes his course and acquires 101 credit points in any form that person will be Simple member of the Organization. Their application will be considered by the Working Committee.

Simple member shall be entitled to participate in any seminars time to time and can also nominate their family and friends (five only) for the seminars at a time throughout the year. Their membership with the organization shall be elapsed after 5 years. The Simple member needs to acquire 50 credit points @ 10 per year otherwise his membership shall be cancelled. After the cancellation of the membership he/she can apply again.

After their enlightenment they will be part of the Assistant for two years and then Guardian for three years and gradually to the core members. For this he/she has to apply his candidature to the working committee where the working committee shall decide him/her to be enlightened.

## **Teacher (Acharya)**

Who so ever have the requisite knowledge of the topic can apply to be an Acharya, but they have to undergo the prescribed training conducted by the organisation time to time. They can work either as a Volunteer or honorary. They shall be eligible to conduct seminars and workshops and shall follow the rules and teachings of the organisation. They shall be categorized into four types

Teacher of the Brahma Gyan –Brahamin Class

Teacher of the Shastra Gyan – Kshatriya Class

Teacher of the Vastu Gyan – Vaish Class

## **Student (Shishya)**

Anyone can become a Shishya if he/she agrees to follow the rules and regulations of the organisation by taking admission and completion of the course – Gyanada or any other course. He/she has to fill the required application form and deposit the required fees along with Security deposit (Refundable) in advance and at least acquire 1 credit point.

He/she shall have to give yearly fees regularly in advance and in its failure his/her membership shall be cancelled.

Students up to class 12 and backward class can avail this facility by depositing required yearly fees along with Security Deposit (Refundable). They are entitled to take part freely in seminars held during the year, but have to confirm their presence at least 15 days prior of the seminars.

Any Shishya can qualify to Simple, Assistant or Guardian if he/she is able to produce a research paper and contribute to the Organization during his/her tenure.

## **Seeker**

Anyone can be a Seeker who takes the admission. There is no restriction on age, gender, religion and caste.

## **Special or Sponsored**

Anyone can become a special or sponsored member if he/she sponsor the education of a person months/student or donates. He/she does not need to possess divine attributes at initial level. This category is to develop the divine attributes in that person.

The donation should not exceed the minimum course fees.

He/she has to nominate anyone for the course within six months and in failing the nomination the donation given to the organization will be refunded and his membership shall be cancelled. He/she can complete his/her course and can proceed to another membership. He/she will get a concession of 25% in fees for sponsoring.

## **General Rules**

### **Fees**

All the fees have to be paid in advance.

## **Rules for cancellation of membership**

Any member who likes to end up his/her membership from the organization needs to write an application to the Secretary. The Secretary has the rights to settle his/her dues and refund the Security deposit of the applicant and accept the application.

On application which has a disputed matter would not be acceptable by the Secretary, the Managing committee will settle such matters.

## **Rights of Cancellation of membership**

The managing committee has the full rights to cancel any member's name from the membership, if there is any harm to the Organization or the rules of the Organization not followed by him/her. Their name is to be given in the subject matter of the meeting.

According to the above rules for cancellation of membership the Secretary can ask for reinstallation of the membership to the Committee.

## **Year**

This organization will follow accounting year from 1st April and will end on 31st March the next year.

## **Other Rules:**

- a. Every member who so ever takes admission will be initially a Seeker, but only after the completion of the course and depositing the requisite fee shall be qualified for the next level i.e. Shishya, Assistant or Guardian.
  - b. Every Shishya will be made member of the Organization for at least one year.
  - c. In case of cancellation during the mid of the year, the fee will not be paid back at any case.
  - d. In case of losing the membership card, duplicate can be issued by giving Rs.50/= after verification.
  - e. On completion of the year and not giving the application for cancellation, the yearly fees will be payable by the member.
  - f. All the work of the organisation shall be done in Hindi and English language and all the documents, register will be kept or available in the organisation's office.
  - g. The office of the organisation can be closed during the General Meeting and regular meetings as per the dates.
  - h. Smoking, liquor, drugs, using abusive words, indecent behaviour, sexual content, guns and ammunitions are prohibited in the venue/office of the

organisation.

i. Members are not allowed to sit on the desk, to group for unlawful demand, to raise slogans against anyone which hurts sentiments.

j. The rules can be changed only by Special General Body Meeting in which the majority should be three fourth of the present members. But in no condition the objectives and the Working Committee can be changed which will have three fourth enlightened persons as members. This will never change at any position at any time.
